OFFICIAL CITY COUNCIL PROCEEDINGS REGULAR SESSION JANUARY 17, 2012

A regular session of the Granite Falls City Council was called to order by Mayor David Smiglewski at 7:30 p.m., Tuesday, January 17th, in the Council Chambers of City Hall. Council Members present: DuWayne Galow, Steve Nordaune, Steve Schaub, Joe Fagnano and Scott Peterson. Council Member absent: Bill Miller. Staff present: City Manager Bill Lavin, Finance Director Michael Betker and City Clerk Joan Taylor. Advocate Tribune News Editor Scott Tedrick was also in attendance.

MINUTES: M/S NORDAUNE/SCHAUB TO APPROVE THE MINUTES OF THE JANUARY 3rd REGULAR MEETING. Motion carried unanimously by those present.

BILLS: M/S NORDAUNE/GALOW TO APPROVE BILLS PRESENTED FOR PAYMENT. Motion carried unanimously by those present.

REPORTS: The Airport Commission report was acknowledged at this time.

NPIAS Upon the recommendation of the Airport Commission, Galow introduced a resolution and moved its adoption approving Addendum No. 3 in the amount of \$2,970 to the Professional Services Contract with Bolton & Menk relative to the city's application to have the Granite Falls Municipal Airport placed on the National Plan of Integrated Airport Systems.

WHEREAS pursuant to Resolution No. 11-177 council approved Addendum No. 2 to the engineering contract in the amount of \$6,750 relative to additional costs associated with the city's NPIAS application; and

WHEREAS, Bolton & Menk has submitted Addendum No.3 to

the professional services contract to include additional engineering fees in the amount of \$2,970 relative to updating the NPIAS report for FAA review, attending on-site FAA meeting and to prepare the final report package for a total amount of \$2,970.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF GRANITE FALLS, MINNESOTA, approving Addendum No. 3 as submitted by Bolton & Menk in the amount of \$2,970 relative to additional costs associated with the city's NPIAS application.

WHEREAS, the State Office of Transit is requesting that the city consider revisions to the current drug and alcohol testing policy to incorporate language consist with federal regulations.

BE IT FURTHER RESOLVED that the City of Granite Falls hereby assures the Granite Falls Pedestrian Bridge will be maintained for a period of no less than 20 years.

WHEREAS, the City has retained Ehlers & Associates, Inc., in Roseville, Minnesota ("Ehlers"), as its independent financial advisor for the Bonds and is therefore authorized to solicit proposals in accordance with Minnesota Statutes, Section 475.60, Subdivision 2(9);

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Granite Falls, Minnesota, as follows:

- 1. <u>Authorization; Findings</u>. The City Council hereby authorizes Ehlers to solicit proposals for the sale of the Bonds.
- 2. Meeting; Proposal Opening. The City Council shall meet at 7:30 p.m. on February 21, 2012, for the purpose of considering sealed proposals for and awarding the sale of the Bonds.
- 3. <u>Official Statement</u>. In connection with said sale, the officers or employees of the City are hereby authorized to cooperate with Ehlers and participate in the preparation of an official statement for the Bonds and to execute and deliver it on behalf of the City upon its completion.
